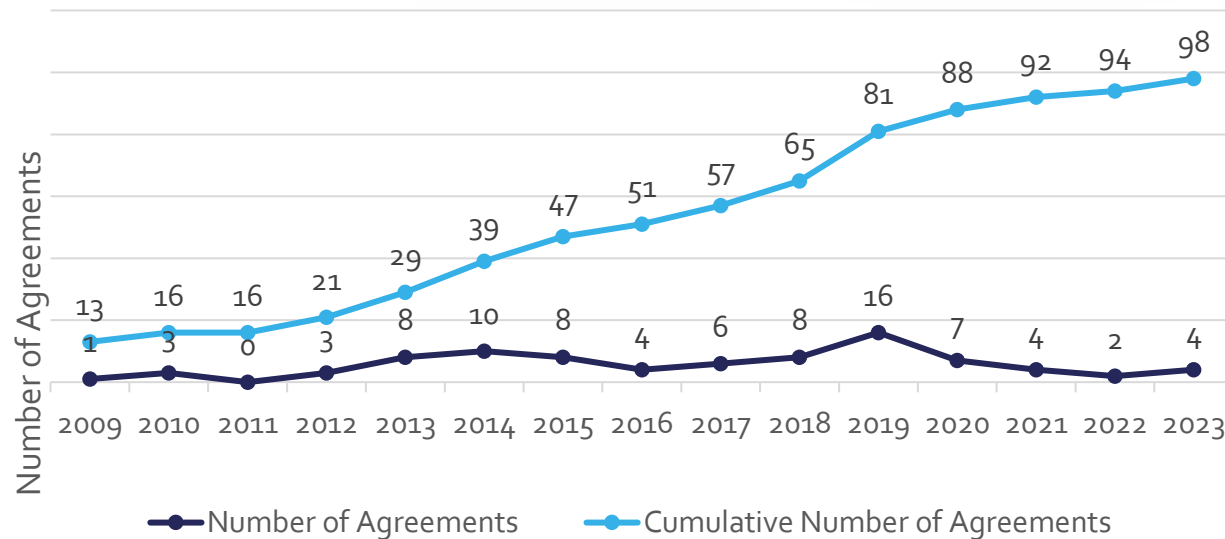

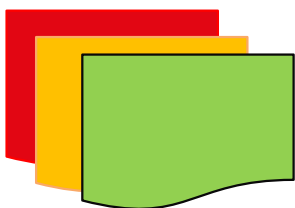

# Evaluation Aspect

## Evaluation:

The support decision of the project proposal is taken by the TEYDEB Group Executive Committee, taking into account the independent expert reports.

The evaluation of the projects is carried out according to the criteria in 4 dimensions.



### 1. Dimension

- Industrial R&D content of the project, its innovation level and technological merit



### 2. Dimension

- Relevance of project plan with planned activities and the technical and managerial capability of the firm



### 3. Dimension

- Economic potential of the final outcome and its contribution to national economy



### 4. Dimension

- International characteristic of the project

# Eligible Costs

- Personnel cost
- Travel expenditures of personnel and consultants
- Expenditures for instruments, equipment, computer software that would be used for R&D purposes
- Direct expenditures for materials etc.
- Expenditures for consultancy services and other services need for R&D work
- Expenditures for R&D that was conducted by universities, public & private research organizations
